INTRODUCTION:

Two Feathers Native American Family Services vision is to empower local Native American youth and families to realize and live out their true potential. We serve all Native youth and families in Humboldt County. To achieve our goal of building thriving Native American communities, we work with Native youth and families by providing culturally based, youth driven interventions that promote holistic health and wellness.

Two Feathers has grown ten-fold in the last three years, from a team of four to a team of 26 staff and multiple consultants. In 2020, the California State Assembly recognized our work for "invaluable healthcare contributions that will continue to build generations of healthy Indian communities."

THE OPPORTUNITY:

Under the supervision of Two Feathers Executive Director, this individual will be responsible for the development, implementation, management and oversight of Two Feathers clinical operations including, but not limited to, grants, contracts compliance, staffing and supervision, budgets, reporting, and program development. The Licensed Clinical Supervisor provides overall administrative direction and organization leadership as related to program and grant requirements.

KEY RESPONSIBILITIES:

Clinical 15%

- Deliver individual psychotherapy to Native American clients.
- Deliver psychotherapy in a group setting to Native American clients.
- Performs detailed patient record documentation and maintains caseload records in compliance with ethical and legal standards and MediCal billing requirements; prepares intake and discharge summaries, progress notes and treatment reviews.
- Assess clients to determine best practices and referrals as needed for their continued recovery and support.
- Conduct assessment interviews with new clients, assess and/or diagnose client needs.
- Participate in case review meetings and staff meetings.
- Provide monthly progress reports.
- Attend appropriate conferences and trainings to enhance education and awareness.
- Work with other community-based agencies and/or referral services.
- Maintain grant paperwork necessary to provide evaluation information, and report information.
- Participate in Two Feathers-NAFS youth and cultural programming.
- Work with other service providers who are part of a client's support team.
- Work collaboratively with Tribal and Native American service programs such as mental health, social services and medical providers.

Managerial 85%

- Coordinate and provide staff training programs, provide daily management and supervision of program staff, including performance review, weekly supervision and feedback meetings, and coaching in program implementation and crisis response.
- Provide weekly clinical supervision to AMFT and ASW licensed clinical interns.
